Before the Court is a joint stipulation entered into by and between Plaintiffs Townsend Vance and Zachary Haines (“Plaintiffs”), Defendant Mazda Motor of America Inc. d/b/a Mazda North American Operations (“Mazda”), and Defendant Denso International America, Inc. (“Denso”) (together with Mazda, “Defendants”) (Doc. 147), by and through their respective counsel, to obtain a one-month extension of certain remaining Settlement Deadlines set forth in this Court’s Preliminary Approval Order (Doc. 144), and to continue the Final Fairness Hearing, currently set for January 17, 2025.

Having reviewed the Parties’ joint stipulation, and for good cause shown, the Court hereby **APPROVES** the Parties’ stipulation. The previously set Settlement Deadlines detailed in the Court’s Preliminary Approval Order (Doc 144) are extended, supplemented, or revised as follows:
